Community Engagement Process

- **Community Meetings:**
60 participants per meeting from across the South Bronx Significant Maritime and Industrial Area (SMIA)
- **Planning Board meetings:**
Continuous support from 19 local stakeholder groups
- **Stakeholder meetings:**
Meetings with other local community groups including those with an environmental justice focus
- **Youth focus group:**
Engaging THE POINT's youth group and other South Bronx youth



Community Feedback

Opportunities/Strategies

Energy:

- Micro-grids
- Community ownership of energy infra.
- Clean, renewable energy

Waterfronts & open space:

- Access to waterways (rowing, sailing)
- Greenways moving people to higher ground & buffer zones
- Pollution mitigation & storm surge protection via wetlands restoration (recycling water)

Hunts Point Resiliency

- The City has \$45 million of Community Development Block Grant Disaster Recovery (CDBG-DR) funding to advance resiliency in Hunts Point
- Two feasibility studies for energy resiliency and flood risk reduction
- Conceptual design and environmental review for a resilient energy pilot project

Other Opportunities



REVitalize: Hunts Point

- Advocate for a strong commitment from The City to pursue the best possible scenario for the energy pilot project for the community, while creating renewable energy sources to reduce the current reliance on diesel for emergency power generation.
- To assess the viability of a business model that includes community co-ownership of any major infrastructure projects, so these interventions can also result in local revenue that benefits the community
- To pursue distributive energy resource solutions (i.e., community shared solar), and other opportunities to address the high energy burden in the residential community

REVitalize: Potential Outcomes

- A plan that generates comprehensive energy solutions that address the energy needs of both the residential and industrial communities in Hunts Point
- A business plan that includes co-ownership, training and local hiring strategies for the community
- A community that is mobilized and engaged in active decision-making around clean energy solutions for the Hunts Point Peninsula

NYSERDA will support the planning of community-scale clean energy projects that benefit low-income and EJ communities through two components:

1. Provide funding through a competitive solicitation to community-based organizations (CBOs) that provide services or otherwise represent low-income or EJ communities to aid the planning and development of a community-scale clean energy project.
2. Development of guidance/toolkits to bridge knowledge and technical gaps, accelerate project development timelines, and help to replicate the planning and development process across the state.
