What Is The New York Voucher Incentive Program?

The **New York Truck Voucher Incentive Program (NYTVIP)**, administered by NYSERDA, helps make it easier for fleets to acquire clean technology vehicles while removing the oldest, dirtiest diesel engines from New York roads through point-of-sale vouchers for new vehicles. What Is The Role Of The Scrappage Operator?

Scrappage facilities play a large role in ensuring the program's success and mission to cut vehicle emissions statewide. Program applicants seeking vouchers for new vehicles are required to scrap the qualifying (old) truck. Scrappage of the qualifying trucks can only be completed at a program-verified scrappage facility. Learn more below on how to become a NYTVIP-certified scrappage facility.

What Are The Scrappage Requirements?

- The vehicle dealer and purchaser(s) will coordinate with the eligible scrappage facility for old diesel vehicle pickup and transfer to the scrappage operator for retirement.
- The vehicle must arrive at the scrappage facility with the chassis intact, the engine intact, and in drivable condition.
- Vehicles will be rendered inoperable and available for recycling by:
 - o Cutting a 3-inch hole in the engine block for all engines;
 - and the chassis disabled by cutting the frame rails completely in half.
- Scrappage facilities will demonstrate compliance by documenting the scrapped vehicles in a series of "Before" and "After" photographs. A list of required photographs will be provided to the scrappage facility.
- Upon completion of scrappage, the New York State Department of Environmental Conservation (NYSDEC) Scrappage Certification Form must be completed, signed, and returned to NYSERDA.
- Scrappages may be subject to verification/audit such as randomized on-site visits with prior consent provided by the scrappage facility.
