


**Highlights**

- Mid-Atlantic ultra-low sulfur (ULS) distillate inventories increased 2.1 million barrels (10.6%) since last week to 21.4 million barrels. Current inventories are 3.1% ahead of last year’s level but 14.8% below the 5-year average.
- For the week ending January 11<sup>th</sup>, New York statewide heating degree-days (212) were less than last year (230) by 7.8% and less than the 30-year normal (265) by 20.0%.
- The New York Statewide average retail price of ultra-low sulfur (ULS) heating oil decreased while the average prices of kerosene and propane increased since the last survey.

**Retail Petroleum Prices**—On a statewide basis since the last survey on January 6<sup>th</sup>, the price decreased \$0.017/gallon (0.5%) to \$3.312/gallon for ULS heating oil, prices increased \$0.006/gallon (0.2%) to \$3.714/gallon for kerosene, and \$0.002/gallon (0.1%) to \$2.884/gallon for propane. Compared to a year earlier, prices increased \$0.114/gallon (3.6%) for heating oil, \$0.103/gallon (2.9%) for kerosene, and the price decreased \$0.077/gallon (2.6%) for propane.

**Crude Oil Prices**—For the week ending 1/10/2020, WTI crude oil spot prices averaged \$60.84/bbl, a decrease of \$0.78/bbl (1.3%) from the week-ago average of \$61.62/bbl. WTI prices are now \$10.06/bbl (19.8%) above the year-ago weekly average of \$50.78/bbl. The all-time weekly average high of \$142.52/bbl occurred on 7/04/08.

**Spot Natural Gas Prices**—For the week ending 1/10/2020, Henry Hub natural gas spot prices averaged \$2.066 per million Btu (mmBtu), an increase of \$0.041/mmBtu (2.0%) from the prior week level of \$2.025/mmBtu. Prices are currently \$0.794/mmBtu (27.8%) below the year-earlier weekly average of \$2.860/mmBtu.



**Residential Natural Gas Prices**—The NYS average price in October 2019 was \$1.643/therm, a decrease of \$0.299/therm (15.4%) from the September 2019 price of \$1.942/therm, and was \$0.020/therm (1.2%) lower than the year earlier average of \$1.663/therm.

**Historic Retail Prices**—Statewide average high and low prices since Sept. 1997 for heating oil & propane & Sept. 2000 for kerosene.


- Heating oil—highest price \$4.778/gallon on 7/14/08, lowest price \$0.876/gallon on 9/08/98.
- Propane—highest price \$3.811/gallon on 2/17/14, lowest price \$1.072/gallon on 9/20/99.
- Kerosene—highest price \$5.068/gallon on 7/14/08, lowest price \$1.309/gallon on 9/09/02.



**New York State Regions:** *Long Island:* Nassau and Suffolk *New York City:* Bronx, Kings, New York, Queens, and Richmond *Lower Hudson:* Dutchess, Putnam, Rockland, and Westchester *Upper Hudson:* Columbia, Greene, Orange, Sullivan, and Ulster *Capital District:* Albany, Fulton, Montgomery, Rensselaer, Saratoga, Schenectady, Schoharie, and Washington *North Country:* Clinton, Essex, Franklin, Hamilton, Jefferson, Lewis, St. Lawrence, and Warren *Central:* Broome, Cayuga, Chenango, Cortland, Delaware, Herkimer, Madison, Oneida, Onondaga, Oswego, Otsego, Tioga, and Tompkins *Western:* Allegany, Cattaraugus, Chautauqua, Chemung, Erie, Genesee, Livingston, Monroe, Niagara, Ontario, Orleans, Schuyler, Seneca, Steuben, Wayne, Wyoming, and Yates counties. **Propane & Kerosene:** *Mid-Hudson:* Columbia, Dutchess, Greene, Orange, Putnam, Rockland, Sullivan, Ulster, and Westchester counties. **Heating Degree Days**— On a statewide basis during the past week, the number of heating degree-days (212) was 7.8% below the year-ago level (230) and 20.0% below the normal trend (265). On a cumulative basis since October 1<sup>st</sup>, current year heating degree-days (2,506) are behind the year-ago level (2,535) by 1.1% and behind the normal trend (2,539) by 1.3%.









**Retail Btu Price Equivalents**—The New York State heating fuel prices Btu graph equates the retail price for New York State wide average residential ultra-low sulfur heating oil, kerosene, propane, and natural gas on a dollar per million Btu (MMBtu) basis.



Note: Natural gas prices are from the U.S. EIA and provided on a monthly basis and delayed by 3 months. The monthly average price of natural gas is higher during the summer months due to low delivery volumes and fixed delivery charges and does not necessarily indicate a higher underlying supply price. Higher average natural gas prices in the summer months are not indicative of higher future prices during the winter months.

**Spot Btu Price Equivalents**—The Btu spot market graph equates the spot market price, in table below, for NY Harbor ultra-low sulfur diesel fuel and 0.3% sulfur high pour #6 residual fuel, Mont Belvieu propane, and the New York Citygate natural gas price on a dollar per million Btu (MMBtu) basis.






**Statewide Forecast HDD:** On a statewide basis for the week ending January 18<sup>th</sup>, the number of forecasted heating degree-days (205) is 27.6% below last year (283) and 24.1% below the normal trend (270). Regional HDD forecasts are provided in the map and table below.
