


**Highlights**

- Mid-Atlantic ultra-low sulfur (ULS) distillate inventories increased 3.2 million barrels (15.3%) since last week to 23.6 million barrels. Inventories are 40.6% above the year-ago level and 11.7% above the 5-year average.
- The weekly average U.S. WTI crude oil spot price increased \$7.75 per barrel (49.3%) since last week to \$23.46 per barrel. Current prices are \$38.35 per barrel (62.0%) below the year-ago weekly average of \$61.81 per barrel.
- New York Statewide average retail prices of ultra-low sulfur (ULS) heating oil, kerosene, and propane all decreased since the last survey.

**Retail Petroleum Prices**—On a statewide basis since the last survey on April 27<sup>th</sup>, prices decreased \$0.163/gallon (6.8%) to \$2.235/gallon for ULS heating oil, \$0.083/gallon (2.7%) to \$2.941/gallon for kerosene, and \$0.219/gallon (8.0%) to \$2.515/gallon for propane. Compared to a year earlier, prices decreased \$1.015/gallon (31.2%) for heating oil, \$0.704/gallon (19.3%) for kerosene, and \$0.400/gallon (13.7%) for propane.

**Crude Oil Prices**—For the week ending 5/8/2020, WTI crude oil spot prices averaged \$23.46/bbl, an increase of \$7.75/bbl (49.3%) from the week-ago average of \$15.71/bbl. WTI prices are now \$38.35/bbl (62.0%) below the year-ago weekly average of \$61.81/bbl. The all-time weekly average high of \$142.52/bbl occurred on 7/04/08.

**Spot Natural Gas Prices**—For the week ending 5/8/2020, Henry Hub natural gas spot prices averaged \$1.830 per million Btu (mmBtu), an increase of \$0.132/mmBtu (7.8%) from the prior week level of \$1.698/mmBtu. Prices are currently \$0.728/mmBtu (28.5%) below the year-earlier weekly average of \$2.558/mmBtu.



**Residential Natural Gas Prices**—The NYS average price in February 2020 was \$1.131/therm, an increase of \$0.025/therm (2.3%) from the January 2020 price of \$1.106/therm, and was \$0.021/therm (1.9%) higher than the year earlier average of \$1.110/therm.

**Historic Retail Prices**—Statewide average high and low prices since Sept. 1997 for heating oil & propane & Sept. 2000 for kerosene.


- Heating oil—highest price \$4.778/gallon on 7/14/08, lowest price \$0.876/gallon on 9/08/98.
- Propane—highest price \$3.811/gallon on 2/17/14, lowest price \$1.072/gallon on 9/20/99.
- Kerosene—highest price \$5.068/gallon on 7/14/08, lowest price \$1.309/gallon on 9/09/02.



**New York State Regions:** *Long Island:* Nassau and Suffolk *New York City:* Bronx, Kings, New York, Queens, and Richmond *Lower Hudson:* Dutchess, Putnam, Rockland, and Westchester *Upper Hudson:* Columbia, Greene, Orange, Sullivan, and Ulster *Capital District:* Albany, Fulton, Montgomery, Rensselaer, Saratoga, Schenectady, Schoharie, and Washington *North Country:* Clinton, Essex, Franklin, Hamilton, Jefferson, Lewis, St. Lawrence, and Warren *Central:* Broome, Cayuga, Chenango, Cortland, Delaware, Herkimer, Madison, Oneida, Onondaga, Oswego, Otsego, Tioga, and Tompkins *Western:* Allegany, Cattaraugus, Chautauqua, Chemung, Erie, Genesee, Livingston, Monroe, Niagara, Ontario, Orleans, Schuyler, Seneca, Steuben, Wayne, Wyoming, and Yates counties. **Propane & Kerosene:** *Mid-Hudson:* Columbia, Dutchess, Greene, Orange, Putnam, Rockland, Sullivan, Ulster, and Westchester counties. **Heating Degree Days**—Until the start of the next heating season in October, the heating degree-day information below reflects weekly information through April 25, 2020. Cumulative statewide heating degree-days from October 1<sup>st</sup> through April 25<sup>th</sup> end the current season at 5,368, which is behind the year-ago level (5,728) by 6.3% and behind the normal trend (5,737) by 6.4%.






**Propane Stocks**—Current and historic heating fuel inventory data is presented in the graphs below.




**Retail Btu Price Equivalents**—The New York State heating fuel prices Btu graph equates the retail price for New York Statewide a verage residential ultra-low sulfur heating oil, kerosene, propane, and natural gas on a dollar per million Btu (MMBtu) basis.



Note: Natural gas prices are from the U.S. EIA and provided on a monthly basis and delayed by 3 months. The monthly average price of natural gas is higher during the summer months due to low delivery volumes and fixed delivery charges and does not necessarily indicate a higher underlying supply price. Higher average natural gas prices in the summer months are not indicative of higher future prices during the winter months.

**Spot Btu Price Equivalents**—The Btu spot market graph equates the spot market price, in table below, for NY Harbor ultra-low sulfur diesel fuel and 0.3% sulfur high pour #6 residual fuel, Mont Belieu propane, and the New York Citygate natural gas price on a dollar per million Btu (MMBtu) basis.





**Weather Outlooks** – Based on data and maps provided by the National Oceanic and Atmospheric Administration (NOAA) and the Northeast Regional Climate Center at Cornell University (NRCC).

**Statewide Forecast HDD:** On a statewide basis for the week ending May 16<sup>th</sup>, the number of forecasted heating degree-days (80) is 5.9% below last year (85) and 37.9% above the normal trend (58). Regional HDD forecasts are provided in the map and table below.


