


**Highlights**

- Mid-Atlantic propane inventories decreased 160,000 barrels (3.1%) since last week to 5.051 million barrels. Inventories are 26.9% below the year-ago level but are 5.3% above the 5-year average.
- Mid-Atlantic ultra-low sulfur (ULS) distillate inventories decreased 0.2 million barrels (0.7%) since last week to 35.3 million barrels. Inventories are 67.3% above the year-ago level and 33.1% above the 5-year average.
- New York Statewide average retail prices of ultra-low sulfur (ULS) heating oil and kerosene decreased while the average retail price of propane increased since the last survey.

**Retail Petroleum Prices**—On a statewide basis since the last survey on September 7<sup>th</sup>, prices decreased \$0.015/gallon (0.6%) to \$2.359/gallon for ULS heating oil, \$0.038/gallon (1.3%) to \$2.903/gallon for kerosene, and the price increased \$0.001/gallon (0.0%) to \$2.454/gallon for propane. Compared to a year earlier, prices decreased \$0.784/gallon (24.9%) for heating oil, \$0.654/gallon (18.4%) for kerosene, and \$0.331/gallon (11.9%) for propane.

**Crude Oil Prices**—For the week ending 9/11/2020, WTI crude oil spot prices averaged \$37.38/bbl, a decrease of \$4.46/bbl (10.7%) from the week-ago average of \$41.84/bbl. WTI prices are now \$18.78/bbl (33.4%) below the year-ago weekly average of \$56.16/bbl. The all-time weekly average high of \$142.52/bbl occurred on 7/04/08.

**Spot Natural Gas Prices**—For the week ending 9/11/2020, Henry Hub natural gas spot prices averaged \$2.155 per million Btu (mmBtu), a decrease of \$0.009/mmBtu (0.4%) from the prior week level of \$2.164/mmBtu. Prices are currently \$0.449/mmBtu (17.2%) below the year-earlier weekly average of \$2.604/mmBtu.



**Residential Natural Gas Prices**—The NYS average price in June 2020 was \$1.561/therm, an increase of \$0.437/therm (38.9%) from the May 2020 price of \$1.124/therm, and was \$0.095/therm (5.7%) lower than the year earlier average of \$1.656/therm.

**Historic Retail Prices**—Statewide average high and low prices since Sept. 1997 for heating oil & propane & Sept. 2000 for kerosene.


- Heating oil—highest price \$4.778/gallon on 7/14/08, lowest price \$0.876/gallon on 9/08/98.
- Propane—highest price \$3.811/gallon on 2/17/14, lowest price \$1.072/gallon on 9/20/99.
- Kerosene—highest price \$5.068/gallon on 7/14/08, lowest price \$1.309/gallon on 9/09/02.




**Heating Degree Days**—Until the start of the next heating season in October, the heating degree-day information below reflects weekly information through April 25, 2020. Cumulative statewide heating degree-days from October 1<sup>st</sup> through April 25<sup>th</sup> end the current season at 5,368, which is behind the year-ago level (5,728) by 6.3% and behind the normal trend (5,737) by 6.4%.








**Propane Stocks**—Current and historic heating fuel inventory data is presented in the graphs below.



**Retail Btu Price Equivalents**—The New York State heating fuel prices Btu graph equates the retail price for New York State wide average residential ultra-low sulfur heating oil, kerosene, propane, and natural gas on a dollar per million Btu (MMBtu) basis.

**Spot Btu Price Equivalents**—The Btu spot market graph equates the spot market price, in table below, for NY Harbor ultra-low sulfur diesel fuel and 0.3% sulfur high pour #6 residual fuel, Mont Belieu propane, and the New York City gate natural gas price on a dollar per million Btu (MMBtu) basis.



Note: Natural gas prices are from the U.S. EIA and provided on a monthly basis and delayed by 3 months. The monthly average price of natural gas is higher during the summer months due to low delivery volumes and fixed delivery charges and does not necessarily indicate a higher underlying supply price. Higher average natural gas prices in the summer months are not indicative of higher future prices during the winter months.

**Weather Outlooks** – Based on data and maps provided by the National Oceanic and Atmospheric Administration (NOAA) and the Northeast Regional Climate Center at Cornell University (NRCC).

**Statewide Forecast HDD:** On a statewide basis for the week ending September 19<sup>th</sup>, the number of forecasted heating degree-days (20) is 33.3% above last year (15) and 20.0% below the normal trend (25). Regional HDD forecasts are provided in the map and table below.


