


**Highlights**

- Mid-Atlantic ultra-low sulfur (ULS) distillate inventories decreased 0.6 million barrels (3.0%) since last week to 18.6 million barrels. Inventories are 44.2% below the year-ago level and 30.1% below the 5-year average.
- The weekly average U.S. WTI crude oil spot price increased \$0.49 per barrel (0.7%) since last week to \$72.18 per barrel. Current prices are \$32.40 per barrel (81.4%) above the year-ago weekly average of \$39.78 per barrel.
- New York Statewide average retail prices of ultra-low sulfur (ULS) heating oil, kerosene, and propane all increased since the last survey.

**Retail Petroleum Prices**—On a statewide basis since the last survey on September 20<sup>th</sup>, prices increased \$0.045/gallon (1.4%) to \$3.245/gallon for ULS heating oil, \$0.007/gallon (0.2%) to \$3.651/gallon for kerosene, and \$0.024/gallon (0.8%) to \$3.026/gallon for propane. Compared to a year earlier, prices increased \$0.879/gallon (37.2%) for heating oil, \$0.754/gallon (26.0%) for kerosene, and \$0.558/gallon (22.6%) for propane.

**Crude Oil Prices**—For the week ending 9/24/2021, WTI crude oil spot prices averaged \$72.18/bbl, an increase of \$0.49/bbl (0.7%) from the week-ago average of \$71.69/bbl. WTI prices are now \$32.40/bbl (81.4%) above the year-ago weekly average of \$39.78/bbl. The all-time weekly average high of \$142.52/bbl occurred on 7/04/08.

**Spot Natural Gas Prices**—For the week ending 9/24/2021, Henry Hub natural gas spot prices averaged \$4.954 per million Btu (MMBtu), a decrease of \$0.412/MMBtu (7.7%) from the prior week level of \$5.366/MMBtu. Prices are currently \$3.274/MMBtu (194.9%) above the year-earlier weekly average of \$1.680/MMBtu.



**Residential Natural Gas Prices**—The NYS average price in July 2021 was \$2.057/therm, an increase of \$0.358/therm (21.1%) from the June 2021 price of \$1.699/therm, and was \$0.185/therm (9.9%) higher than the year earlier average of \$1.872/therm.

**Historic Retail Prices**—Statewide average high and low prices since Sept. 1997 for heating oil & propane & Sept. 2000 for kerosene.


- Heating oil—highest price \$4.778/gallon on 7/14/08, lowest price \$0.876/gallon on 9/08/98.

- Kerosene—highest price \$5.068/gallon on 7/14/08, lowest price \$1.309/gallon on 9/09/02.




**Heating Degree Days**—Until the start of the next heating season in October, the heating degree-day information below reflects weekly information through April 24, 2021. Cumulative statewide heating degree-days from October 1<sup>st</sup> through April 24<sup>th</sup> end the current season at 5,287 HDDs, which is behind the year-ago level (5,328) by 0.8% and behind the normal trend (5,699) by 7.2%.









**Retail Btu Price Equivalents**—The New York State heating fuel prices Btu graph equates the retail price for New York State wide average residential ultra-low sulfur heating oil, kerosene, propane, and natural gas on a dollar per million Btu (MMBtu) basis.



Note: Natural gas prices are from the U.S. EIA and provided on a monthly basis and delayed by 3 months. The monthly average price of natural gas is higher during the summer months due to low delivery volumes and fixed delivery charges and does not necessarily indicate a higher underlying supply price. Higher average natural gas prices in the summer months are not indicative of higher future prices during the winter months.

**Spot Btu Price Equivalents**—The Btu spot market graph equates the spot market price, in table below, for NY Harbor ultra-low sulfur diesel fuel and 0.3% sulfur high pour #6 residual fuel, Mont Belieu propane, and the New York City gate natural gas price on a dollar per million Btu (MMBtu) basis.





**Statewide Forecast HDD:** On a statewide basis for the week ending October 2<sup>nd</sup>, the number of forecasted heating degree-days (28) is 86.7% above last year (15) and 46.2% below the normal trend (52). Regional HDD forecasts are provided in the map and table below.



