

Highlights

- Mid-Atlantic gasoline stocks decreased 1.1% from the previous week and are now 6.6% below last year's level and 7.6% below the 5-year average.
- Mid-Atlantic ultra-low sulfur diesel stocks declined 5.4% since last week and have decreased by over 6.7 million barrels or 35% since mid-October but remain 7.8% above last year's levels.
- The weekly average European Brent crude oil spot price equaled \$76.63/bbl, \$34.69/bbl (31.2%) lower than last year's price and is the lowest weekly average price since September 2010.

Retail Prices

Prices are from the "AAA Daily Fuel Gauge Report."

Regular Gasoline— For the week ending December 1st, the New York State weekly retail gasoline price averaged \$3.179/gallon, a decrease of \$0.042/gallon (1.3%) from last week's average price of \$3.221/gallon. Compared to the year earlier price of \$3.644/gallon, the statewide average has decreased \$0.465/gallon (36.1%).

The all-time high of \$4.309/gallon occurred on July 9th, 2008.

Diesel— For the week ending December 1st, the New York State weekly retail diesel price averaged \$3.792/gallon, a decrease of \$0.022/gallon (0.6%) from last week's average price of \$3.814/gallon. Compared to the year earlier price of \$4.153/gallon, the statewide average has decreased \$0.361/gallon (8.7%).

The all-time high of \$5.138/gallon occurred on June 18th, 2008.

Crude Oil Spot Prices

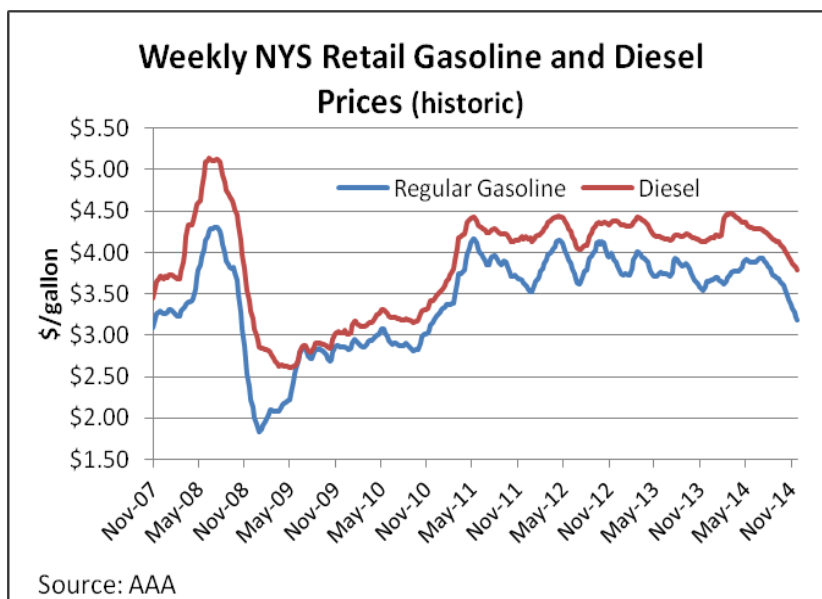
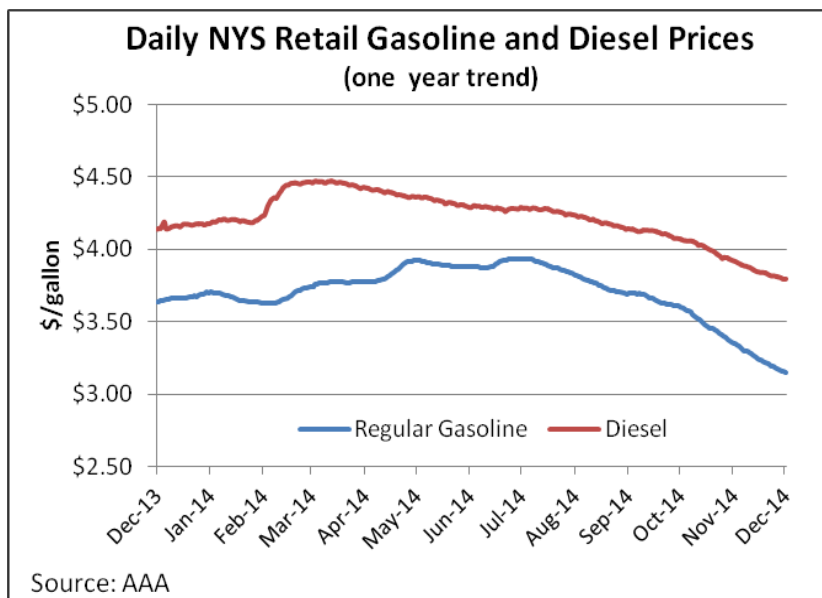

WTI—For the week ending November 28, 2014, WTI crude oil spot prices averaged \$72.36/bbl, a decrease of \$3.02/bbl (4.0%) from the prior week average of \$75.38/bbl. WTI prices are now \$20.61/bbl (22.2%) below the year-ago weekly average of \$92.97/bbl.

The all-time weekly average high of \$142.52/bbl occurred the week ending July 4th, 2008.

Brent—For the week ending November 28, 2014, Brent crude oil spot prices averaged \$76.63/bbl, a decrease of \$0.99/bbl (1.3%) from the week-ago average of \$77.62/bbl. Brent prices are now \$34.69/bbl (31.2%) below the year-ago weekly average of \$111.32/bbl.

The all-time weekly average high of \$141.07/bbl occurred the week ending July 4th, 2008.

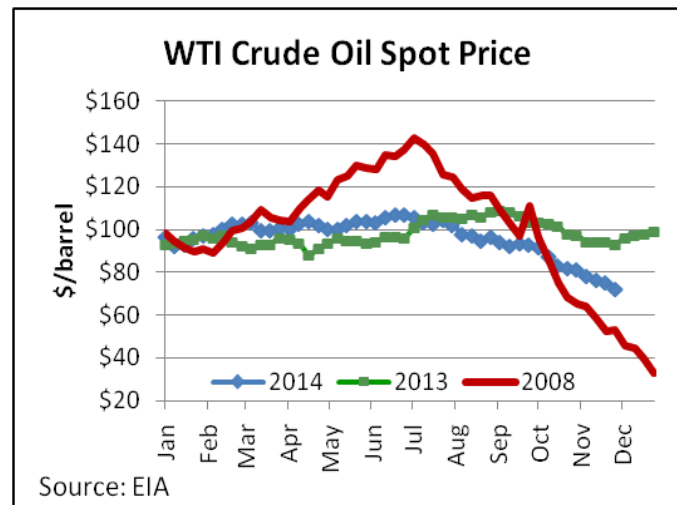
