I understand that this information will be kept confidential, to the extent permitted by law, and used only for the purpose of determining program eligibility, estimating energy savings, program implementation, and evaluation, including the evaluation of achieved energy savings. I agree to provide NYSERDA with information about any energy efficiency upgrades made to this home within the next three (3) years by completing an online, mailed or phone survey.

I understand that the energy savings numbers provided to me are estimates only and are not guaranteed by either my auditor or the New York State Energy Research and Development Authority. I acknowledge that the energy savings information from the Residential Energy Assessment Summary Report may vary from energy savings calculations provided by my contractor through energy modeling simulation tools.
