COVID-19 State, Programmatic and Regulatory Responses and Industry Input





Introduction

- Electric vehicles and EV charging stations are critical components of the State's policy objectives
- COVID-19 represents significant challenges
- Public health must be our #1 priority
- Staff have been directed to identify actions that should be considered to maintain progress and position us well post COVID-19
- Striving for effective communication and consistent guidance

We are Open for Business

New York State, including NYSERDA, DPS, and our utility partners, are open for business

- All teams are working remotely, and you can access any of us by email or phone
- The Drive Clean Rebate and NYTVIP application portals are open, and we are accepting new project applications and processing payments
- The Charge Ready NY application portal is temporarily closed, but we are still processing existing applications
- DPS working groups are continuing to meet virtually for example: the EV Make-Ready Conference and EV Readiness Working Group

Essential & Non-Essential Construction

- Per the Governor's <u>Executive Orders</u>, health and safety of New Yorkers is priority number one
- All program activity requiring in-person presence at a project site that is not defined as Essential or Emergency-related shall pause through April 29, unless extended by future Executive Orders
- Empire State Development (ESD) updated which projects are considered essential construction in the FAQ link on their site
- Essential or Emergency means necessary to maintain the health, welfare and safety of New York residents

Non-Essential Clean Energy Construction

Non-Essential clean energy construction includes all the following:

- Energy efficiency work
- New power generation including solar and wind
- Interconnection field construction
- New energy storage
- New EV infrastructure

Operations and maintenance of existing power generation systems including already operating solar, energy storage and EV infrastructure is allowed but must follow all DOH requirements.

COVID-19 Temporary Program Changes

Drive Clean Rebate

- Car dealers may continue to submit new applications and updated information for previously submitted applications. NYSERDA will extend the allowable period for submissions for recent sales beyond the typical 60 days.

NY Truck Voucher Incentive Program

- Truck and bus dealers may continue to submit new voucher applications and additional documentation for previously submitted applications and previously approved vouchers. NYSERDA will extend the allowable period for deliveries of vehicles on an as needed basis.

COVID-19 Temporary Program Changes

Charge Ready NY

- New program applications will not be accepted starting April 3, until further notice. Charging equipment owners may continue to submit documentation for previously submitted applications. NYSERDA will extend the allowable period for installations of pre-approved charging stations beyond 180 days on an as needed basis and will extend the period for applying to Charge Ready NY after an installation is completed beyond 90 days for stations installed since January 1, 2020. NYSERDA will provide additional information on program deadlines in the future.

Utility EV Charging Infrastructure Work

Financial Assistance Resources

<u>Federal Paycheck Protection Program</u>: Max of \$10 million for businesses with fewer than 500 employees. Loan payments deferred 6 months. If you maintain your workforce, SBA will forgive loan proceeds used to cover the first 8 weeks of payroll and certain other expenses. This is first come, first served.</u>

SBA Economic Injury Disaster Loans: up to \$2 million in working capital to impacted businesses to help overcome temporary loss of revenue. Can pay operating expenses. Interest rate is 3.75% for small businesses with long-term repayment options up to 30 years.

<u>NYC Small Business Employee Retention Grant</u>: covers 40% of payroll costs for two months to help NYC small businesses with fewer than 5 employees retain employees.

<u>New York City Small Business Continuity Fund</u>: interest-free loans up to \$75,000 for NYC businesses with less than 99 employees.
