Unlocking sites for development of renewable energy facilities

Through the Build-Ready Program, the New York State Energy Research and Development Authority (NYSERDA) is working to advance the development of renewable energy resources and accelerate progress toward New York's nation-leading clean energy and climate goals.

Time is money. Build-Ready speeds up the siting and development of renewable energy facilities on landscapes that present complicated development challenges for commercial developers. NYSERDA minimizes conflicts and competition with commercial developers while also advancing appropriate renewable energy projects through the development process. Projects on this scale benefit from the support, collaboration and partnerships the Build-Ready Program provides to eventual project developers.

This work fosters and encourages local understanding about the importance of renewable energy and the value it can bring to local communities, including environmental justice impacts. By putting underutilized and difficult sites to productive use, the Build-Ready Program can bring cash flow to communities and put them on the path to a clean energy economy.

Site selection

NYSERDA works with other state, regional, and local agencies; private companies; communities and elected officials; and other stakeholders to identify suitable sites for the development of renewable generation facilities and makes them Build-Ready for competitive auction to renewable energy developers in the private sector. Priority is given to previously developed sites, existing or abandoned commercial sites, brownfields, landfills, former commercial or industrial sites, dormant electric generating sites, and sites otherwise underutilized.

NYSERDA will work cooperatively with commercial developers. To ensure Build-Ready complements the efforts of private sector developers and does not displace them, potential sites are screened for local conflicts and competition. Some sites may pose challenges, receiving only limited attention by private sector developers or commercial development. Particularly challenging sites may benefit from NYSERDA support or potential participation in Build-Ready.

Identification of active development

Individuals and entities such as landowners and developers can propose sites for potential Build-Ready assessment through a Standard Site Recommendation form. In addition providing background information on a site, the answers will help NYSERDA determine whether a commercial renewable energy developer has expressed a prior or ongoing material interest in the site. The answers will help NYSERDA determine whether a commercial renewable energy developer has expressed a prior or ongoing material interest in the site.

Form questions will include:

- Has this site been reviewed for renewable energy before?
- If so, why were plans abandoned?
- If applicable, who was the developer, individual, or company who reviewed the site?

Another approach to assess commercial developer interest in a potential site early in the process is to conduct an active development investigation.

This investigation will include:

- Discussions with the site owner.
- Discussions with any potential developer identified by the site owner or through the Site Recommendation Form.
- Examination of the NYISO interconnection queue to determine if any studies are ongoing for the site.
- Discussions with permitting authorities to determine if any party has engaged in permit related discussions or activities for the site.

Through this investigation, if it is determined there is ongoing active development by a commercial developer, NYSERDA will withdraw from further interaction for a sufficient period of time to allow both the site owner and commercial developer(s) to advance development of the site. NYSERDA may periodically reach out to the site owner and/or commercial developer to assess progress. If at any time during this follow-up period development challenges for the site or a waning interest of the site owner or commercial developer becomes evident, NYSERDA will engage in discussions with both the site owner and commercial developer to see if there is any benefit to moving the site into the Build-Ready program.
