As tenants of substantial commercial office space in New York City, law firms are uniquely positioned to use energy efficiency to align themselves with their clients, improve their spaces, and signal their leadership on carbon reduction efforts.

Many law firm clients are increasingly focused on sustainability. In NYC, landlords and commercial tenants are implementing energy efficiency improvements to trim operating expenses and help reduce the carbon footprint of their city's buildings, which account for nearly 70%¹ of NYC's total greenhouse gas emissions. Energy efficiency improvements recently implemented at a large commercial office space leased by a law firm in NYC have resulted in an annual cost savings of \$385,000, with payback in approximately one year.

NYSERDA's Commercial Tenant Program **can provide up to 100% of the cost of an energy analysis**, the first tool you'll need to improve the energy efficiency of your space.

Basic Track



³ (1) NYSERDA will reimburse 100% of the cost of the energy analysis if the tenant installs all recommended energy efficiency upgrades with a payback period of less than three years OR (2) NYSERDA will reimburse the installation costs of any recommended energy efficiency measures, in each case up to the cost of the energy analysis or \$50,000, whichever is lower.
