
Highlights

- Mid-Atlantic ultra-low sulfur (ULS) distillate inventories decreased 1.5 million barrels (7.5%) since last week to 19.0 million barrels. Current inventories are 8.8% below last year's level and 25.5% below the 5-year average.
- The weekly average WTI crude oil spot price decreased \$2.43 per barrel (4.1%) to \$56.90 per barrel since last week. The weekly average is now 21.9% below last year's level of \$72.84 per barrel.
- New York Statewide average retail prices of ultra-low sulfur (ULS) heating oil, kerosene, and propane all decreased since the last survey.

Retail Petroleum Prices—On a statewide basis since the last survey on September $23^{\rm rd}$, prices decreased \$0.012/gallon (0.4%) to \$3.168/gallon for ULS heating oil, \$0.008/gallon (0.2%) to \$3.580/gallon for kerosene, and \$0.005/gallon (0.2%) to \$2.780/gallon for propane. Compared to a year earlier, prices decreased \$0.156/gallon (4.7%) for heating oil, \$0.066/gallon (1.8%) for kerosene, and \$0.142/gallon (4.9%) for propane.

Crude Oil Prices—For the week ending 9/27/19, WTI crude oil spot prices a veraged \$56.90/bbl, a decrease of \$2.43/bbl (4.1%) from the week-ago average of \$59.33/bbl. WTI prices are now \$15.94/bbl (21.9%) below the year-ago weekly a verage of \$72.84/bbl. The all-time weekly a verage high of \$142.52/bbl occurred on 7/04/08.

Spot Natural Gas Prices—For the week ending 9/27/19, Henry Hub natural gas spot prices a veraged \$2.494 per million Btu (mmBtu), a decrease of \$0.166/mmBtu (6.2%) from the prior week level of \$2.660/mmBtu. Prices are currently \$0.578/mmBtu (18.8%) below the year-earlier weekly average of \$3.072/mmBtu.



Residential Natural Gas Prices—The NYS average price in July 2019 was \$1.930/therm, an increase of \$0.273/therm (16.5%) from the June 2019 price of \$1.657/therm, and was \$0.019/therm (1.0%) lower than the year earlier a verage of \$1.949/therm.






Heating Degree Days— Until the start of the next heating season in October, the heating degree-day information below reflects weekly information through April 27, 2019. Cumulative statewide heating degree-days from October 1st through April 27th end the current season at 5,740, which is a head of the year-ago level (5,739) by 0.0% and ahead of the normal trend (5,722) by 0.3%.















Statewide Forecast HDD: On a statewide basis for the week ending October 5th, the number of forecasted heating degree-days (39) is 62.5% more than last year (24) and 33.9% less than the normal trend (59). Regional HDD forecasts are provided in the map and table below.
