Outreach and Marketing

Fourteen CBOs were selected through a competitive process for the GJGNY Outreach Program through (RFP 2038). The awards represent \$5,148,719 of the \$6 million allocated for constituency-based outreach. CBOs receiving contracts are:

Based on these awards, and to address gaps in coverage, NYSERDA issued a second competitive solicitation on June 6, 2011. RFP 2327, Green Jobs – Green New York Outreach Program, offers awards as delineated below of up to a total of \$1,000,000. The due date for these Outreach Proposals is July 12, 2011. The total number of Home Performance with ENERGY STAR projects completed in May was 409, bringing the total since January 1, 2011 to 2,995. Fifty-two percent of completions in May originated from a GJGNY audit. This reflects consistent growth in the percentage of project completions originating with a GJGNY audit over the initial months of the program from 8% in January, 19% in February 28% in March, 48% in April, to 52% in May. However, 52% is lower than the program team would have anticipated based on the number of months since program launch. NYSERDA will investigate the program processes to ensure the project origination data is being correctly documented in the data systems.

The conversion rate from completed audit to project contract averages 28%– 30%, which is considered to be an acceptable number for this stage of the program.

Tier 2 criteria for the GJGNY residential loan allows a prospective borrower with a FICO score less than 640 to qualify for financing if they have demonstrated a good payment history on energy bills and their mortgage. Of the applicants that were denied financing under Tier 1, approximately 7% were reviewed under the alternate Tier 2 standards. The most significant reason for loan denial (~45%) is a Debt to Income Ratio (not to exceed 50% under Tier 1 or 55% for Tier 2, including the requested loan amount). NYSERDA is currently evaluating the effectiveness of the underwriting criteria in qualifying applicants for financing to support energy efficiency upgrades, and may revise the underwriting criteria to increase the availability of financing to additional homeowners while still maintaining an appropriate level of security for the loan program and potential investors.

RFP 2198 seeking a Green Jobs-Green New York Master Loan Servicer was issued on February 17, with proposals due of March 21, 2011. A TEP was held on April 14, and contract negotiations are currently underway with the selected proposer. Once a contract has been executed with the Master Loan Servicer, a new PON will be issued seeking Participating Lenders to originate GJGNY residential energy loans, with collection services provided by the Master Loan Servicer.

*Projects may choose to proceed outside MPP. Some may chose smaller work scopes which will not achieve program standard and thus not be eligible for MPP and some may elect to access utility incentives. If energy efficiency projects are completed, building owners that have an authorized audit would still be eligible to apply for GJGNY financing.

**MPP Projects must achieve a minimum of 15% in Energy Savings.

Small Business / Not-For-Profit

The FlexTech program was expanded in January 2011 in support of the GJGNY legislation. GJGNY energy audits are now offered statewide at no charge to small businesses and not-for-profits with an average electric demand of 100kW or less and ten employees or less. As of April 30, 125 GJGNY audits have been completed. For participants ineligible for GJGNY audit funding, FlexTech also uses American Recovery and Reinvestment Act (ARRA) funding to provide free energy audits to any small business¹ or not-for-profit with an average electric demand of 100 kW or less. Small businesses and not-for-profits can also obtain qualified energy audits through their utility service provider and still be eligible for GJGNY energy efficiency loans.

The Small Business/Not-for-Profit revolving loan fund is currently seeking lenders through PON 2293 (<u>http://www.nyserda.org/funding/2293pon.asp</u>.) NYSERDA will work with lenders statewide to provide eligible small

businesses and not-for-profits, that have qualified energy audits, access to low-interest GJGNY energy project financing. NYSERDA will provide lenders 50% of the principal of an eligible GJGNY loan, up to \$26,000, at a 0% interest rate. The lender will provide the remainder of the principal at market rate. Through participation in the loan program, lenders will be able to offer blended interest rates at approximately half the market rate. NYSERDA is coordinating with utilities and others to incorporate the financing opportunity into marketing and outreach materials.

Evaluation

Discussions continued between Energy Analysis, program staff, and the evaluation contractors on program objectives and anticipated evaluation needs. The discussions have identified the need for initial work to focus on Process and Market Characterization and Assessment efforts. The work plans for these initiatives are currently under final review and the survey instruments are in the initial stages of development. Energy Analysis staff anticipates initiating the data collection for this effort mid summer with an estimated final report available March 2012.
