NYSERDA will finance 50% of the Eligible Loan Amount, approved by NYSERDA on this Request for Financing Form, up to a maximum of \$50,000, at 2% interest. The Lender will finance the remaining loan principal at market rate. Participating Lenders will screen Applicants for credit worthiness. Lenders will only issue Participation Loans to Applicants that meet or exceed the Lender's criteria. Criteria may vary by Lender. Borrowers will make loan payments to the participating Lender.	A participating Lender of the Applicant's choice offers NYSERDA loans of up to \$50,000 at 2.5% interest. Participating Lenders will screen Applicants for credit worthiness. Lenders will only issue On-Bill Recovery Loans to Applicants that meet or exceed NYSERDA's criteria. - 1) I am an eligible Applicant, as defined in the Section 2 of this document, and have the authority to make and install the proposed improvements;
- 2) All information in this Request for Financing Package is true and complete to the best of my knowledge and belief;
- 3) I will complete my energy efficiency project and submit a Certificate of Project Completion to NYSERDA within 90 days of receiving the energy efficiency loan from my Lender;
- 4) I understand and agree to the following Terms and Conditions:

Eligible Loan Amount. NYSERDA reserves the right to deny all or some portion of the Request for Financing Package, or adjust incentive amounts for individual measures, listed in the Approved Energy Efficiency Measures Worksheet, and thereby reduce the Eligible Loan Amount.

Access to Credit Information. A lender or NYSERDA has the right to access a credit report(s), a FICO score, and perform similar credit-related activities for the purpose of evaluating my creditworthiness.

Follow-up Visits. NYSERDA reserves the right to make a reasonable number of post-installation follow-up visits to the project during the 24 months following the project completion. Such visit(s) will be at a time convenient to the Applicant and will be made with at least one week's advance notice to the Applicant. The purpose of the follow-up visit(s) is to provide NYSERDA or its agent an opportunity to ensure the Approved Measures are installed consistent with the Request for Financing Package, and generally accepted engineering practices.

Limited Scope of Review. The scope of review by NYSERDA of the installation of Approved Measures is limited solely to determining whether criteria set forth in the Request for Financing Package have been met and does not include any kind of safety or other review.

Title to Equipment. Title to equipment purchased under this Application shall not vest with NYSERDA.

No Warranties. NYSERDA does not endorse, guarantee, or warrant any particular manufacturer or product, and NYSERDA provides no warranties, expressed or implied, for any product or services. The Applicant acknowledges that neither NYSERDA nor any of its agents are responsible for ensuring that the design, engineering, construction, or installation of the Approved Measures is proper or complies with any particular laws, codes, or industry standards.

Indemnification. The Applicant shall protect, indemnify, and hold harmless NYSERDA and the State of New York from and against all liabilities, losses, claims, damages, judgments, penalties, causes of action, costs and expenses (including, without limitation, attorney's fees and expenses) imposed upon or incurred by or asserted against NYSERDA, its agents, or the State of New York resulting from, arising out of, or relating to the performance of this Agreement. The obligations of the Applicant under this section shall survive any expiration or termination of this Agreement. Application Does Not Entitle Applicant to Participate Submission of a completed application does not entitle the applicant to program participation.

Vendor Selection. The Applicant may select any vendor or contractor to perform the work included in the Request for Financing Package. NYSERDA expects the Applicant to competitively procure products and services related to this Request for Financing Package. Notwithstanding the foregoing, the Applicant acknowledges that NYSERDA has the right to exclude a vendor or contractor from participating in this program.

Events of Default by Applicant. An Event of Default shall be deemed to exist if any one or more of the following events occurs:

- a. Failure to comply with the approved Request for Financing Package, including the Terms and Conditions contained herein;
- b. Omissions or misrepresentation of material facts attested to in the Request for Financing Package regarding the eligibility of the facility, the Applicant, or the improvements;
- c. Failure of the Applicant to complete the Approved Measures as set forth in the Request for Financing Package;
- d. Failure of the Applicant to provide NYSERDA or its agents reasonable access to the facility for the purpose of monitoring, inspecting, or otherwise investigating the installation of the Approved Measures; or
- e. Failure of the Applicant to submit the Certificate of Completion. In the Event of a Default, NYSERDA reserves rights to all remedies available under law.
