
#### **Tier 1/ Tier 4 Interaction**




### 2021 Tier 1 Solicitation

#### > RESRFP21-1 released on April 22.

- Fifth annual Tier 1 solicitation under the Clean Energy Standard (CES) for new large-scale renewables generation, seeking approximately 4.5 million megawatt-hours of annual generation.
- First Tier 1 solicitation under the modified Clean Energy Standard, updates approved by the October 2020 Order Adopting Modifications to the CES to align with the Climate Leadership and Community Protect Action.

#### Progress to 70% Renewable by 2030



All contracted project information available via Open NY

#### Since 2018, **Over 90 projects 10,800+ MW**

- > Includes recently announced awards for 2 new offshore wind projects and 22 large-scale solar, hydroelectric, and energy storage projects across upstate New York, totaling over 4,600 MW of new renewable capacity and 30 MW of energy storage capacity.
- > RESRFP21-1 supports continued progress to further develop 30+ million megawatthours of renewable generation to achieve New York's 2030 energy targets.

### Tier 1/ Tier 4 Interaction

Starting point: facilities participating in Tier 4 (T4RFP21-1) are permitted to participate and bid in Tier 1 RESRFP21-1 and vice versa.

- > To participate in either Tier 1 and/or Tier 4, the facility in question needs to win an award under, and comply with the requirements for, the Tier in question.
- > Participation in one Tier does not automatically ensure participation in the other, eg a Tier 4 Resource can only sell RECs to NYSERDA under Tier 1 if it has also obtained a Tier 1 award.
- > A facility with an award under both Tiers may choose to generate and be compensated for each MWh under either Tier as it sees fit (subject of course to meeting the requirements of the Tier in question). E.g., a facility awarded a Tier 1 and Tier 4 agreement might choose to generate only under Tier 1 during a period after the facility's commercial operation date (COD) where the Tier 4 New Transmission has not yet achieved COD.
- > Tier 1 facilities that achieved COD before October 15, 2020 are not eligible for Tier 4.

### Participation of Projects With Existing Tier 1 Award in Tier 4

#### Tier 4 RFP section 2.4:

For eligible Resources that have an existing or have been awarded a Tier 1 agreement and are included as Resources in a Tier 4 Proposal selected in this Tier 4 procurement, NYSERDA will agree to amend the Tier 1 agreement to accommodate sales of RECs as either Tier 1 or Tier 4 RECs. For example, to allow for Tier 4 sales, NYSERDA would amend certain terms in the Tier 1 agreement to allow the Resource to deliver RECs under either agreement.

#### Tier 1 Agreement amendments:

- Principle: the Tier 1 Agreement will be amended to reflect the manner in which the resource intends to participate in the Tier 4 portfolio.
- Incorporate settlement provisions in Tier 1 agreement to ensure that the resource can receive REC payment for all eligible renewable MWh with neither gaps nor double-counting.
- Minimum bid quantity and other terms in the Tier 1 Agreement will be conformed to enable
  participation in both Tier 1 and Tier 4 by the same resource without penalty. Tier 1 terms that obligate
  the seller to meet annual delivery requirements at 80% of the minimum bid quantity (or similar) will be
  amended so that the delivery requirement may be satisfied through both programs cumulatively.

### Participation of Tier 4 Resources in Future Tier 1 RFPs

#### Tier 4 RFP section 2.4:

Resources that do not have a Tier 1 agreement and are included as Resources in a Proposal that is awarded a Tier 4 agreement (or subsequently added to the Project through modification of the Agreement) may participate in a future Tier 1 solicitation subject to Tier 1 eligibility requirements. The Tier 1 agreement, if awarded, will include appropriately flexible terms to allow for sales as either Tier 1 or Tier 4 RECs.

- > Similar provisions as noted on the last slide will be incorporated into future Tier 1 Agreements for facilities that have already been accepted for a Tier 4 award and subsequently receive a Tier 1 award.
- > Upon conclusion of the Tier 4 RFP, NYSERDA may consider doing so using a standard amendment for future Tier 1 Agreements.

# Tier 1/ Tier 4 – Economic Benefits and Reporting

- Sellers will remain obligated under the Tier 1 Agreement's pre-COD quarterly reporting, economic benefits, and contract security provisions without regard to their participation in Tier 4
- > For facilities participating in both RESRFP21-1 and T4RFP21-1, all eligible economic benefits claimed under a pending Tier 4 proposal may also be claimed as part of a Tier 1 Bid Proposal.
