## **Background:**

In the January 16, 2020 Order Authorizing Utility Energy Efficiency and Building Electrification Portfolios through 2025 ("Order"), the New York State Public Service Commission directed the New York Utilities and NYSERDA to develop and implement a Statewide LMI Portfolio to improve access to programs, overall customer experience, and impact for customers in the LMI sector. In accordance with the Order, the New York Utilities and NYSERDA will develop and file an LMI Implementation Plan outlining the goals and components of the Statewide LMI Portfolio on May 15, 2020.

To inform the development of the LMI Implementation Plan, the New York Utilities and NYSERDA will host three Regional Virtual Stakeholder Meetings to receive feedback and input from market participants.
