

New York State Appliance and Equipment Efficiency Standards



Overview – Foodservice Equipment

New York State has adopted appliance and equipment efficiency regulations that will impact what products can be legally sold, rented, leased, and installed in New York as a result of the [Advanced Building Codes, Appliance and Equipment Efficiency Standards Act of 2022](#)¹.

Manufacturers who sell their products in New York State will be required to meet the performance, testing, and certification requirements for products manufactured on and after **June 26, 2023**. Each product will need to be certified to the [State Appliance Standards Database \(SASD\)](#)² in order to be legally sold or offered for sale, leased or offered for lease, or rented or offered for rent in the state.

Retailers, distributors, and installers of the following products should verify their products are compliant by confirming that their offerings are listed in the [SASD](#). Products *manufactured* before June, 26 2023, do not need to comply with this regulation.

Commercial ovens	Align with ENERGY STAR V2.2	CO, MA, NV, NJ, RI, WA
Commercial steam cookers	Align with ENERGY STAR V1.2	CO, DC, MD, MA, NV, NJ, OR, RI, VT, WA
