## Take Action, Earn Points, Gain Rewards

The Clean Energy Communities program opens exciting new opportunities for municipalities across New York State to bring energy efficiency and renewable energy actions, guidance, funding, and recognition to communities. **The program and the rewards are more impactful, innovative, and sustainable than ever before.** Communities now can earn larger grant funding by completing even more High Impact Actions.

Communities will use a point system to earn Designation Grants by completing energy-saving High Impact Actions Communities can also earn grant funding by completing Community Campaign High Impact Actions.

- Communities with populations of 40,000 and over can earn up to \$1.25M.
- Communities with populations under 40,000 can earn up to \$687,500.
- Communities that earn grants larger than \$5,000 are eligible for a bonus grant of up to 50% of their earned grant amount for implementing projects in disadvantaged communities.
